Symptom	Probable Cause	Solution
Arm lifts up and down too easily or with difficulty.	Arm lift tension needs adjustment	10
Monitor/keyboard tilts too easily or with difficulty.	Monitor/keyboard tilt needs adjustment.	11
Monitors pivot from side- to-side too easily or with difficulty	Monitor portrait/landscape needs adjustment.	12
Keyboard tray tilts up and down too easily or with difficulty	Keyboard tray tilt needs adjustment	12
Monitor rotates from portrait to landscape too easily or with difficulty.	Monitor portrait/landscape needs adjustment.	13
Monitors are not level	Crossbar needs to be adjusted clockwise or counterclockwise	14
